- IV. Interim Superintendent's Report
 - A. Enrollment 720 which will be used for our ADA submission
 - MAP program runs regularly 10-15 students on Mondays with all but two being staff kids
 - B. School Safety Training Update Six new candidates for the School Defender program were training this past weekend and all passed. There were 45 staff members that were interested in completing the program at the beginning of the year and we will continue training as scheduling permits.
 - C. TEA Contact Update Tioga ISD is under TEA Fiscal Management Review. TEA has requested documentation which the District Administration has submitted. TEA will provide us with a recommendation on how to move forward.
