- IV. Superintendent's Report
 - A. Volunteer Project(s) Updates Mr. Ballinger advised that the spirit of volunteerism is alive and well in Tioga. There are several projects around the district that are being worked on by volunteers. One of them being the baseball field where the Rainey family and Tri-Tex Grass have been working to get the field ready for the upcoming season.
 - B. 2023 AFR Update Mr. Ballinger gave a brief update including the downgrades on Moody & Standard & Poors financial ratings.
 - C. Discussion held regarding maintenance contracts versus in-house maintenance. Three bids received for HVAC maintenance: Brad Bates, McDaniels and Trane No action was taken.

- A. Jana Hansen advised 340 enrollment at the elementary campus with a 96% attendance rate this month. Elementary UIL hosted contact with eight other districts attending and Tioga placed 5th overall. 3rd 5th grade will be taking an interim STAAR soon.
- B. Keith Kirkland advised that Semester Exams would be on Wednesday and Thursday this week. Exemptions were established tied to attendance. We had good participation for the Middle School UIL, but would like to see more students get involved. Our Forensics classes just completed a crime scene Gingerbread project and our FCS classes created characters based on books written by our elementary students. Basketball is beginning district play. FCCLA Leadership shopped for the Angel Tree and our Girls Basketball teams participated in the Wreaths Across America.
