## VI. Discussion and/or Action Items

- A. Approved the waiver that allows Tioga ISD to continue as a Title 1, A campus for the upcoming year despite a low economically disadvantage student population. Motion made by Stacy Price and seconded by Dallas Slay to allow the requirements per TEA waiver. The motion carried unanimously. (7-0)
- B. Approved the School District Tax Roll Values for 2022 from the office of Bruce Stidham, Tax Assessor-Collector. Motion made by Brandon Miller and seconded by Dugan Rainey. The motion carried unanimously. (7-0)
- C. Mr. Ballinger reviewed the Final FIRST rating for FY 21, which resulted in a "F" rating and a corrective action plan will be required by TEA. Due in January 2023.
- D. The Hearing Date for FIRST Rating of FY 21 was set for December 12, 2022 as part of the December Regular School Board Meeting. Motion made by Stacy Price and seconded by Ryan Walters to set the date as presented. The motion carried unanimously. (7-0)
- E. Review Financial Committee Member Applications and Recommended Placements Members established and recommendations were put together after a review of the submitted applications. Two different subcommittees were established under the finance committee heading. Goals were established as part of the document presented and Debbie Cabrera will continue as the sole financial consultant because of her ties with ESC Region 10. Motion made by

- F. The annual financial report (audit) for Fiscal Year 22 was presented by auditor Shawn Nesmith. Discussion of deficit in the general fund and the issues that creates for the district were extensive. Motion made by Brandon Miller and seconded by Dallas Slay to accept the AFR as presented. The motion carried unanimously. (7-0)
- G. The need to declare financial exigency for Fiscal Year 23 was presented and a resolution of the board of trustees was approved. Motion made by Dallas Slay and seconded by Stacy Price for the declaration. The motion carried unanimously. (7-0)
- H. Motion was made by Stacy Price; seconded by Paul Rodarmer to approve with a single motion, the October check payments, bank financial reports and minutes from the previous meetings. The motion passed unanimously (7-0)
